On 11/20/61 SA W. HARLAN BROWN received, in person, a handwritten report dated 11/18/61 from DL-6-S. This report has been serialized as 134-1A-640.

Informant determined on 11/18/61 that on that date BILL LOWERY contacted JOE LANDIN at his home and asked him if he had (on knew) someone in the Forum he (LANDIN) could get to bring up a resolution condemning the John Birch Society. LOWERY felt that the forum should make its protest public - for even the President had spoken against it. JOE LANDIN liked the idea and said he would ask a close friend of his and a Forum member to do it. The person was IDA MORENO.

Informant determined on 11/20/61 that BILL LOWERY had notified JOE LANDIN on that date that the CP's regular meeting was at the same time, same place which means 8:00 PM at ESTRADA's home on that night, 11/20/61.

Informant had no additional information.
