On 1/16/64, SA W. HARLAN BROWN received, in person, a handwritten report, dated 1/13/64, from DL-6-S. This report has been serialized as 134-1A-810A

Informant determined that ALBERT OROZCO, a G. I. Forum member, contacted JOE LANDIN. In their conversation, OROZCO told LANDIN that JOE MOLINA had been fired from his job. He understood MOLINA had hired attorney MULLINAX but did not know what MOLINA was going to do.

OROZCO, at a recent District meeting of the forum, had reported MOLINA's plight. Among those present were Attorneys CALDERON and ED IDAR. Dr. HECTOR GARCIA, Forum founder, was present also. They were willing to come to Dallas and talk and help MOLINA. OROZCO was sure that at least one of these persons will talk to MOLINA. It was suggested mainly by these three (CALDERON, IDAR and GARCIA) that they should talk to MOLINA and BILL LOWERY together. They would like to know just what the latter's work was with the FBI. This suggestion was made after OROZCO told them that if he or any other member of the forum, simply for being a Forum member, was to be persecuted now or later, they could have the Forum. OROZCO told LANDIN that he was reluctant on taking such steps since he had not consulted MOLINA about it. In fact, there has been no contact between the Forum and MOLINA. ALBERT OROZCO felt that he had done the right thing. MOLINA, he recalled, had worked there for a long time, why was he, he wondered, singled out. LANDIN agreed that he had done the right thing.

Informant had no additional information.
