Enclosed herewith are six copies of an LHM relating to the captioned individual.

ReBulet Page 3, Paragraph 2, refers to the report of SA THEODORE N. GOBLE dated 3/11/58, at Washington, D.C., (WDC), captioned "WALTER MICHAEL FITZMAURICE, was, REGISTRATION ACT", and notes on Page 4 that EDWARD MOSS, 1025 Connecticut Avenue, WDC, contacted FITZMAURICE in October, 1957.

ReBulet Page 3, Paragraph 1, refers to report of SA GERARD C. CARROLL dated 6/27/58, at WDC, captioned "ABELARDO LUNA VALENCIA, REGISTRATION ACT", and notes on Page 2 the report sets forth information concerning an attempted contact by EDWARD MOSS, 1025 Connecticut Avenue, WDC, with VALENCIA.

WFO was requested to report the association by MOSS with FITZMAURICE and VALENCIA as noted, and to characterize those individuals.

A review of WFO files on FITZMAURICE and VALENCIA disclosed investigation in both instances for possible violation of the Foreign Agents Registration Act (FARA) was predicated upon information furnished by GEORGE PEABODY.

As no subversive activities against the United States were disclosed on the part of either FITZMAURICE or VALENCIA during the investigation of those individuals, it would appear any association by MOSS with them is not pertinent and cannot be considered as derogatory or affecting the evaluation of his loyalty or suitability in any way. In addition, it is noted the only contact by MOSS with either FITZMAURICE or VALENCIA was at the specific request of GEORGE PEABODY, the complainant, in an effort by PEABODY to determine the position and status of FITZMAURICE and VALENCIA, for the reasons mentioned above, information relating to the contact by MOSS with FITZMAURICE and VALENCIA has not been included in the LHM enclosed.

It is further noted reBulet requests WFO to report the results of a check of ONI records. The files of ONI were checked on MOSS during the 1952 Loyalty of Government Employees investigation and found to contain no record of him. As the SF 85 submitted in connection with his current employment shows no naval service subsequent to 1948, a recheck of ONI records was not requested.

The source referred to in the LHM enclosed, is WF 1086-C, whose identity is known to the Bureau, information attributed to that source is contained in WFO file 137-8.

The LHM has been classified "Secret" as it includes information from WFO report dated 10/30/52, entitled "UNKNOWN SUBJECT, Aviation Week Issues of 7/21, 28/52 ESPIONAGE - X," so classified. Further, the LHM includes information reflecting an investigative interest in diplomatic personnel.
