~~CONFIDENTIAL SOURCE~~ IS (S) (MM 4086-0A) WHO ALSO HAPPENS TO BE THE INDIVIDUAL SELECTED TO SERVE AS AN ENVOY TO MEXICO OF THE "CORU" ORGANIZATIONS. THE ASSET, IF AGREEABLE TO THE MEXICAN GOVERNMENT, WOULD BE GOING TO MEXICO ON FRIDAY, AUGUST 6, 1976. IT IS BEING REQUESTED OF THE BUREAU THAT AUTHORIZATION BE GRANTED TO MM 4086-0A TO TRAVEL TO MEXICO CITY AS THE REPRESENTATIVE, IF THE MEXICAN GOVERNMENT AGREES TO MEET WITH THE ENVOY IN MEXICO. SHOULD ASSET TRAVEL TO MEXICO, IT IS FELT THAT HIS POSITION WITHIN THE "CORU" AND VARIOUS ANTI-CASTRO TERRORIST GROUPS WILL BE GREATLY ENHANCED, AND HE WILL THEN BE ABLE TO PROVIDE EXCELLENT INFORMATION REGARDING THE ACTIVITIES AND PLANS OF THESE TERRORIST GROUPS, BOTH WITHIN AND OUTSIDE THE U.S., NOTING THAT AT THIS TIME, THESE GROUPS ARE GENERALLY OPERATING OUT OF MIAMI, FLA. AREA, AND ARE, THEREFORE, PROBABLY IN VIOLATION OF THE NEUTRALITY ACT.

~~BUREAU REQUESTED TO SEND COPY OF THIS TELETYPE TO LEGAT, MEXICO FOR THEIR INFORMATION, NOTING THAT ASSET IS A HIGHLY-PLACED SOURCE OF CONTINUING VALUE~~ BECAUSE OF ASSET'S POSITION, AT THIS TIME, LEGAT, MEXICO SHOULD NOT DISSEMINATE ABOVE INFORMATION TO MEXICAN AUTHORITIES, AS SAME COULD WELL COMPROMISE ASSET.
