By airtel 8/24/64, the Jackson Office advised that the Assistant District Attorney at Gulfport, Miss., advised he did not feel there was sufficient basis to request FBI assistance to locate the subject under the UFAC statute. The Assistant DA requested, however, that the Bureau, if information as to DOLAN's whereabouts is ascertained, immediately notify the DA in order that the subject's arrest can be effected by local authorities.

Investigation by Dallas during the past week to ascertain if DOLAN had returned to Dallas was conducted without any pertinent information being developed.

that STONE's brother, JAMES WOODROW STONE (DL 162-179) returned to his home in Joplin, Missouri, because of the demands of his wife that he do so or get out permanently. (This was confirmed by Kansas City letter to Dallas 8/20/64, which advised that STONE is presently operating the Tropic Club in Joplin and listing an address of Box 293, Route 1, Webb City, Missouri.)

On 8/24/64, a Dallas confidential source (DL 137-1292) advised that PICCOLA was presently booking baseball games and the exhibition football games from his drive-in grocery and liquor store on Haskell Street in Dallas. It was later ascertained by Bureau Agents that this drive-in is located at 1704 South Haskell, that there is an unlisted telephone in the store, and a pay telephone having telephone number TA 3-0788 on the outside of the store. PICCOLA and his wife, JEAN, reside at 3717 Crestview Drive, Dallas, and have telephone number LA 1-0678. Investigation to ascertain if PICCOLA is in violation of any Federal anti-gambling statutes and the extent of his bookmaking operation is being instituted by the Dallas Office.
