NEVADA

VON SIMPONIS came to Los Angeles on the morning of 4/29/64 from Palm Springs, California and returned to Palm Springs late the same day. The purpose of her trip was to renew the lease for the Kings Inn, a bar in Gardena, California. CALIF. NEVADA

LA 4412-C-TE left for Las Vegas on 3/30/64 and met SIMPONIS in the casino of the Dunes Hotel where SIMPONIS was engaged in a card game. SIMPONIS is registered in Room 702 of the Stardust Hotel.

VON SIMPONIS left for Las Vegas on 3/30/64 and took her son with her. On Saturday, 4/2/64, LA 4412-C-TE took VON apartment hunting in Las Vegas as NICK is interested in renting a three bedroom apartment.

Informant took the four cases of liquor previously ordered by SIMPONIS to Las Vegas and SIMPONIS divided the liquor into five cases and cases were given to MILTON JAFFE, MEYER GOLDBERG, SID WYMAN and two unknown individuals.

SALVATORE LOUIS PISCOPO requested LA 4412-C-TE to contact SIMPONIS while in Las Vegas concerning the 1st of the month payment due to NICK LICATA from the Desert Sands Casino and to suggest to SIMPONIS that he, informant, bring
