Appropriate checks should be made at these banks to determine pertinent details of accounts which Callahan may maintain at such banks. Particular attention should be directed toward ascertaining whether any withdrawals in the amount of \$3,200 were made around the date of 3-29-56, when that amount was deposited in the Esco account as noted in rerep. It would be pertinent to determine whether there are indications that funds Callahan claims he borrowed from Cozzi were possibly obtained from personal accounts of Callahan. Of course, all other pertinent details concerning sizeable withdrawals, as well as deposits should be secured.

Suairtel as soon as possible and follow with an investigative report promptly.
