Documents requested in leads in referenced Pittsburgh
report located in possession of PLATO CACHERIS, Department of
Justice Attorney, who will hold them for trial to be produced
by N. C. MC DERMOTT, Postmaster, U.S. Post Office, McKees
Rocks, Pennsylvania, and F. M. LACEY.

While discussing matter, CACHERIS and ABRAHAM PORETZ,
Department of Justice Attorney, stated desire to have all
ESCO checks for 1957 examined for direct and possible indirect
payments to WEINHEIMER during that year, in order to preclude
possible defense assertion that WEINHEIMER had received checks
by registered mail during critical periods.

In order to have pertinent records of ESCO reviewed,
Pittsburgh is requested to immediately contact ESCO, obtain
and forward to WFO:

(1) All ESCO industrial and salary checks for 1957
that have not previously been turned over to the Department;

(2) All payroll records including W-2 Form with
regard to WEINHEIMER's salary or compensation. Should difficulty
be encountered in obtaining these records, sutel Bureau and
WFO by 1/14/60 in order that CACHERIS may issue a subpoena for
ESCO to produce the records before FGJ, WDC, on 1/20/60.
