Attached is a copy of the report of information furnished by PG 601-C relating to EDWARD FRANCIS WEINHEIMER and JACK ARMAND, President of Taxi Cab Drivers Local in Pittsburgh, which occasioned this office's inquiry of the Identification Division regarding present status of EDWARD FRANCIS WEINHEIMER.

Pittsburgh has been advised by Philadelphia that Newark currently has an AR case on WEINHEIMER. Inquiry has been made of that office as to WEINHEIMER's current employment and whether or not there is any indication of which Newark might be aware of the purpose of WEINHEIMER's visit to Pittsburgh.

For the information of the Bureau and Newark, discreet inquiry of GEORGE F. CALLAHAN developed that WEINHEIMER was not in contact with him when in Pittsburgh.

Depending upon the information to be received from Newark or the possibility of their being interested in WEINHEIMER's presence in Pittsburgh in view of their pending investigation, this office has no immediate plans for taking further action in this matter.
