On 10/27/60, the files of the Philadelphia Credit Bureau were checked by IC JOHN F. GUNDERMANN, JR., and a derogatory credit report, dated 9/12/57, was located for FRANK A. KEEGAN, 1410 Dorset Lane, Overbrook Hills, Pa. The file reflected that KEEGAN, a white male, married, was 58 years of age in 1957 and was then employed by the Pennsylvania Department of Highways as an engineer at Haverford, Pa. He was formerly employed by the Amco Custom Brokerage, 50 South Third Street, Philadelphia, Pa. KEEGAN resided at Dorset Lane since 1955 and prior to this resided at 504 South Narberth Avenue, Merion, Pa. The credit file reflected KEEGAN was actually retired although steadily employed. A notation on the file indicated he was a senior partner in the A. Murphy Company, Customs House Brokers, for many years.

On 11/14/60, Mr. PETER SUFFRENDINI, source of information of the Philadelphia Office, advised that FRANK A. KEEGAN resided on Dorset Lane in Overbrook Hills, Pa., and was presently employed by the Pennsylvania Department of Highways, which position he held through political connections. SUFFRENDINI added that he has known KEEGAN in view of KEEGAN's position as water boy of the Philadelphia Eagles football team. SUFFRENDINI advised that KEEGAN is a quiet, mild-mannered individual whose only interest appeared to be professional football.
