Our records reflect no pertinent information which can be identified with the following individuals: [Tom J. Holzbog, Robert D. Walts, Phyllis Yampolsky, and Orville D. Schmidt.] (S)

A file review reflected the following information concerning Martin Greendlinger, 194 Clarkson Avenue, Brooklyn, New York, who was born on March 25, 1932:

On March 13, 1951, Greendlinger attended a meeting of the American Peace Crusade (APC) in Washington, D. C. On June 7, 1951, he volunteered to help distribute APC ballots. On May 3, 1951, he was present at a meeting of the Student Committee for Peace at Cornell University. The Student Committee for Peace is an outgrowth of the APC. The APC has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

On December 10, 1950, Greendlinger attended an executive meeting of the Labor Youth League (LYL) at Cornell University. He also attended an LYL meeting on December 29, 1950, as well as an LYL party on March 11, 1951. The LYL has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

[Greendlinger reportedly supported the program and aims of the Communist Party at Cornell University during the years 1950 through 1951.] The Communist Party has been designated by the Attorney General of the United States pursuant to Executive Order 10450.
