The Tampa Tribune of 9/19/60, Tampa, Fla., daily newspaper, carried article Page 1-B concerning formation of above organization in Tampa. This article stated JOSE IGNACIO RASCO from Miami represented above captioned organization which is a coalition of anti-CASTRO groups. The article further stated RASCO came to Tampa 9/18/60 to form an alliance with an organization headed by RAUL MORAN called Anti-Communist Group to Help in the Liberation of Cuba.

ENRIQUE SOMEILLAN advised on 9/15/60, that the name of Comite de Ayuda a La Revolucion de Cuba (Committee to Aid the Revolution of Cuba) would be changed to Comite Anti-Comunista de Ayuda a La Revolucion de Cuba (Anti-Communist Committee to Aid the Revolution of Cuba). (u)

On 9/19/60, SOMEILLAN advised RASCO led a group of about 40 persons from Miami who met 9/18/60 with above named Tampa Committee. According to SOMEILLAN, no action was taken on 9/18/60 toward organizing a FRD group in Tampa, but another meeting for this purpose is to be held Tuesday, 9/20/60, at
