Enclosed herewith are 9 copies of a letterhead memorandum dated and captioned as above at Miami.

From interviews conducted and material reported herein, it is obvious that the original complaint made against the subject was an attempt by one faction of the MDC to discredit subject.

Subject is a member of the Revolutionary Council and exerts full control and leadership over the MDC. He is well regarded in the anti-CASTRO movement. Accordingly, no further investigation is being conducted and the MDC activity will continue to be reported in the case file for that organization.
