Re my airtel 7/11/60, captioned "RAUL CASTRO, IS - Cuba".

Enclosed are original and 8 copies of a letterhead memorandum setting out information on captioned organization as furnished by Reverend JOSE GONZALO GONZALEZ RUBIO, a priest of the Salesian Order who is temporarily in the United States staying at Mary Help of Christians School, Tampa, Florida. Father GONZALEZ stated he arrived in Miami from Havana July 1, 1960 and in Tampa July 6, 1960. He expects to return to Havana about September 1, 1960. He claims to be active in the anti-CASTRO movements in Cuba mentioned herein, specifically the MRR and the FDR. He requested his identity be concealed. (u)

It is noted the FDR is apparently identical with the organization mentioned in previous correspondence from the Bureau captioned

"CLIP" (u)
