Enclosed are four copies of a letterhead memo concerning information furnished by LA 4350-C on 1/10/62. Due to other matters that had to be discussed with informant and frequency of out-of-town trips made by informant since 9/29/61, it has been administratively impossible to discuss this case in detail with informant at an earlier date.

In view of information furnished by the informant, it does not appear that at this time STEIN is associated to a close degree with the Las Vegas operators. Los Angeles will immediately conduct an investigation in an attempt to develop a substantive violation of the anti-racketeering statute relating to STEIN's reported activities with respect to the La Scala Restaurant.

Upon completion of that phase of investigation, Los Angeles will determine if complete investigation of STEIN's activities regarding HOFFA are warranted or if a direct approach to STEIN would appear to be more productive.
