There are enclosed four copies of a revised letterhead memorandum under above caption. These copies should replace copies of the letterhead memorandum dated 1/11/62 being maintained in Los Angeles files.

In connection with the Los Angeles investigation of Stein in an effort to determine if there is a possible violation of the Anti-Racketeering Statutes the Bureau desires that a thorough, complete background investigation also be made concerning Stein along the lines as previously instructed. This should be handled on a continuous TOP PRIORITY basis. During the investigation of Stein no action should be taken which might jeopardize inquiries being made by your office in connection with case captioned "ARTHUR TROTTER; AR," urfile 92-970.

Los Angeles is instructed to advise the Bureau immediately by airtel the identity of the Agents assigned full-time to this investigation and the date it is expected the investigation will be completed and report submitted.

NOTE: J. A. Kelly, Special Investigative Division, states Los Angeles has been given authority to establish a highly confidential source on the apartment of Arthur Trotter. Kelly had no objection to Los Angeles proceeding with a background investigation on Stein at this time.

The Trotter apartment is reported to be a distribution point for monies being brought in from Las Vegas and information from LA 4350-C indicated that Stein might possibly be involved in distribution of money from Las Vegas.
