According to de TERRA, Col. GOTTLIEB was away during the entire month of August and appeared to be traveling on business. That was the period during which she wrote the large number of checks.

According to de TERRA, Col. GOTTLIEB does not drink, smoke or chase women and is very devoted to his wife. She noted that he is a devouted Jew and that he attends Temple every Friday night and Saturday morning.

de TERRA said that she believes Col. GOTTLIEB owns the Abbett Plastic Machine Corporation which is headquartered in Chicago and which has a branch on West Adams Boulevard in Los Angeles. She recalled that recently GOTTLIEB has purchased a large abount of stock in the greater Arizona Savings Bank. Phoenix, Arizona.

de TERRA related that during the early part of June, 1961, she was employed by a firm of attorneys, Eller and Winton. She stated while employed by that firm, an accountant, who is known by the name of PRINTZ (PH), came into that office and appeared flush and excited. PRINTZ announced that he had just been given a million dollars in cash by a client and was instructed to buy up motels around the country in order to help HOFFA organize motel employees. de TERRA did not know the significance of PRINTZ's announcement and stated it appeared to her that he was so excited over the deal that he just had to blurt it out. She could furnish no actitional information regarding these remarks by PRINTZ.

In view of the above information, Los Angeles is opening a 62 file on Colonel JOHN O. GOTTLIEB in which an investigation will be conducted regarding the \$1,500,000 loan from the Teamsters by Home Service Corporation and the allegations made by LA 4350-C regarding GOTTLIEB. Informant will be thoroughly interviewed regarding Col. GOTTLIEB, at which time a letterhead memo will be forwarded to the Bureau including the information furnished by informant as well as the information furnished by Mrs. de TERRA.
