Re Miami letter dated 10/24/69.

As previously noted, subject was contacted by a Bureau Agent in the vicinity of his residence and an appointment arranged for October 27, 1969. At that time he voluntarily presented himself for interview at the Miami Office and was immediately friendly and cooperative. He readily furnished information concerning his contacts with JOSE CARBONELL MARRERO during the period 1963-1964.

A copy of the FD-302 setting forth details of this interview is enclosed for the information of the Bureau, and this interview will be incorporated in the forthcoming report concerning CARBONELL who is the subject of Bureau file 105-173672.

HERRERO, although somewhat forgetful and confused in recalling past activities, appeared to be genuinely open and sincere in furnishing information to the best of his ability regarding his associations with CARBONELL. It appeared that he had not been knowingly involved in CARBONELL's activities in behalf of the Cuban Intelligence Service. Information obtained from HERRERO coincides closely with that developed in the investigation of this and related cases, and HERRERO appears to be sincerely anti-Communist and pro-U.S. in his political beliefs. He has volunteered to contact this office with any information received in the future regarding CARBONELL or any other pro-CASTRO activity. Accordingly this case is being closed.
