ADMINISTRATIVE

Source T-1 in instant report advised he had received the information concerning the subject, MANUEL ANTONIO VARONA, from BARBARA SUAREZ, who in turn received the information from her deceased husband, Colonel SUAREZ, who was Chief of the Buro de Investigaciones, Havana, Cuba, under the regime of FULGENCIO BATISTA and who was murdered by FIDEL CASTRO's revolutionary forces. ~~(S)~~(u)

According to T-1, BARBARA SUAREZ is a confidential source and he has requested she not be contacted in this matter. She resides at Essex House, 1050 Broad Street, Newark, New Jersey, with other Cuban exiles. ~~(S)~~(u)
