MM T-1 explained that BRAC, in addition to its own files and records, had access to all the records of the Bureau of Investigation, which was a police investigative agency in Cuba prior to January 1, 1959. (u)

MM T-1 explained that the records of BRAC and the Bureau of Investigation never reflected MANUEL ANTONIO VARONA as a communist or involved in any such activities. MM T-1 explained that VARONA is the former Prime Minister of Cuba, and is presently one of the leading figures in the Cuban anti-FIDEL CASTRO movement in the United States. (u)
