On this date, ARAGON advised that he was in telephonic contact with Dr. JOSE MIRO CARDONA and CARDONA advised him that the CIA wanted him to make a trip to Central America and to be out of the US during the period of 6/9 to 6/16/62. MIRO stated that he had already lined up a visit to San Jose, Costa Rica, and was in the process of lining up 4 or 5 other Central American countries to be included on this trip. MIRO indicated to ARAGON that his mission to the Central American countries was twofold, namely, 1. to discourage and forestall any impending military action emanating from this area against Cuba, as action now is believed to be premature; 2. that MIRO will make contact with presidents and various officials in these Central American countries to obtain their permission to train Cubans in their countries for future action against the present Cuban government.

ARAGON stated that MIRO CARDONA was not too specific in relating details regarding the objectives of this trip, but gave every indication that this trip was being made at the request of MIRO's CIA contact in Miami, Florida, who has been previously identified as a Colonel [JOHNSON] (ph).
