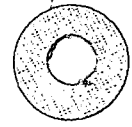

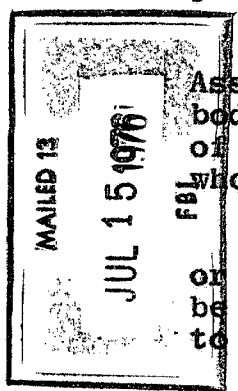

This is to confirm referenced Bureau telephone call granting authority for the use of body recording devices on the person of a confidential source.

Enclosed memorandum reflects approval of Deputy Assistant Attorney General Waldman in connection with the use of body recording devices for a period of 30 days for the purpose of recording conversations the source may have with individuals who may be involved in this case.
