SAN FRANCISCO AIRTEL TO BUREAU DATED JULY 30, 1976.

A MEMORANDUM ATTACHED TO REFERENCED BUREAU AIRTEL REFLECTED DEPARTMENTAL AUTHORIZATION WAS GRANTED ON JULY 14, 1976, FOR A 30-DAY EXTENT IN REGARD TO THE USE OF A MICROPHONE IN THE APARTMENT OF SF 8677-PC.

ON AUGUST 6, 1976, JIMMY FRATIANNO CAME TO PC'S APARTMENT AND THE FOLLOWING INFORMATION WAS OBTAINED THROUGH THE USE OF ELECTRONIC SURVEILLANCE: FRATIANNO MADE A PHONE CALL TO IRVING SHAPERO AND LEFT A MESSAGE THAT DOCTOR SCHWARTZ HAD CALLED. FRATIANNO TELEPHONED GORDON (LNU) AND MENTIONED THE TROPICANA NIGHT CLUB IN LAS VEGAS.

FRATIANNO CALLED PAUL (LNU) AND ADVISED PAUL THAT THE UNION WAS GOING TO STRIKE HIM. HE TOLD PAUL THAT THE GUY HE HAS REPRESENTING HIM IS ONE OF THE MOST HATED MEN BY THE UNION. FRATIANNO REITERATED TO PAUL THAT IF HE HAD THE

MURRAY IN ABOUT TWO WEEKS AND ASKED IF THOSE GUYS ARE ALL RIGHT. JIMMY TOLD MURRAY HE WOULD TALK TO HIM AGAIN IN ABOUT A WEEK. AFTER THE CONCLUSION OF THE ABOVE PHONE CALL JIMMY TOLD THE SOURCE HE SENT FOUR GUYS TO AUSTRALIA TO MAKE SOME DEALS BUT DID NOT SAY WHAT THE DEALS WERE.

FRATIANNO TOLD PC THAT SINIO (PH), AN INDIVIDUAL THAT FREQUENTS SAL'S EXPRESSO CAFE, WAS SENT TO NEW YORK BY FRATIANNO TO BORROW \$20,000 OR \$30,000 FROM A GUY THAT FRATIANNO KNOWS IN NEW YORK. FRATIANNO STATES THAT SINIO RUNS SOME SORT OF A SMALL RESTAURANT IN MARIN COUNTY, MAYBE A PIZZA JOINT.

FRATIANNO CALLS OUT AND ADVISED AN UNKNOWN SUBJECT THAT HE TALKED TO BOB (LNU) ABOUT A TRUCK JOB MONDAY MORNING AT 8:30. JIMMY TELLS UNSUB THAT A GUY HE TALKED TO AN HOUR AGO IS COMING IN TWO WEEKS, POSSIBLY MURRAY FROM AUSTRALIA, AND JIMMY SAYS HE HAS FOUR GUYS OVER THERE NOW.

FRATIANNO TOLD PC THAT HOWARD COOK WAS MAKING SOME SORT OF A BUSINESS DEAL WHICH INVOLVED \$30,000 AND THE

STAGECOACH CAFE ON MONTGOMERY STREET IN SAN FRANCISCO,  
CALIFORNIA.

AFTER FRATIANNO LEFT PC'S APARTMENT PC IMMEDIATELY  
TELEPHONED SA JENKINS AND ADVISED THAT FRATIANNO HAD LEFT  
HIS ADDRESS BOOK AND NUMEROUS BUSINESS CARDS AT HER  
APARTMENT. THE ADDRESS BOOK AND BUSINESS CARDS WERE  
OBTAINED, XEROXED, AND RETURNED TO THE PC WHICH PC RETURNED  
TO FRATIANNO. NUMEROUS NAMES AND TELEPHONE NUMBERS WERE  
OBTAINED FROM THE BUSINESS CARDS AND THE ADDRESS BOOK.

ON AUGUST 10, 1976, SAN FRANCISCO STRIKE FORCE (SFSF)  
ATTORNEY JOHN EMERSON WAS CONTACTED REGARDING A 30-DAY  
EXTENSION OF THE MICROPHONE INSTALLATION IN SOURCE'S  
APARTMENT. EMERSON ADVISED THAT HE AGREED WITH REQUESTING  
ANOTHER 30-DAY EXTENSION FOR USE OF THE MICROPHONES IN  
PC'S APARTMENT AND HE FELT THAT ENTRAPMENT WAS NO PROBLEM.  
EMERSON WAS ADVISED THAT PC WAS STILL WILLING TO TESTIFY  
IN THIS MATTER.
