The Bureau is aware of LARRY J. FLETCHER's incarceration at Federal Reformatory, Chillicothe, Ohio.

On September 24, 1963, CG 5913-C advised SA WILLIAM A. MEINCKE that MIKE LA JOY (subject) and FRANK DELEGGE were meeting with two individuals in the Pan Cake House at Mannheim and Grand, Franklin Park, Illinois. The purpose of these meetings, which occurred during the week preceding September 23, 1963, was for the planning of a crime in this area. The informant identified photographs of subject JOSEPH D'ARGENTO and LARRY J. FLETCHER as being these two other individuals.

It is noted FRANK DELEGGE is the owner of the residence 3115 Dora, Franklin Park, where the getaway car used in instant matter was abandoned.

The Chicago Office has corroborated the fact meetings occurred at this Pan Cake House between LA JOY, DELEGGE, D'ARGENTO and other persons during the week before the robbery. This restaurant is about 1 1/2 miles from the Franklin Park Bank and within one-half mile of 3115 Dora. It is described as a place that was frequented by subjects JOSEPH D'ARGENTO, PAT SCHANG and their associates. These associates include LARRY J.
