TO LEADERS OF ORGANIZED CRIME HERE RE HIS APPEARANCE. *PC INFORMANT*  
STATED BIEBER CLAIMS HE TOOK FIFTH AMENDMENT TO ALL  
QUESTIONS. HOWEVER, *INFORMANT* PC AND OTHER LEADERS MOST CONCERNED AND  
UNTRUSTFUL OF BIEBER. THEY ARE AWARE BIEBER VERY CLOSE  
ASSOCIATE OF MANY CHICAGO MAJOR BURGLARS AND THIEVES AND HIS  
RELATIONSHIP WITH THEM TRANSCENDS ORDINARY RELATIONSHIP BETWEEN  
ATTORNEY AND CLIENT. *INFORMANT* PC STATED FOR THIS REASON HOODLUM LEADERS  
ARE FEARFUL BIEBER, "NOW THAT HE'S IN A BIND," WILL FOLLOW  
THEIR EXAMPLE AND BECOME COOPERATIVE WITH FBI.

PC STATED FBI'S RECENT SUCCESS IN MAKING INFORMANTS OUT  
OF "EVERY BURGLAR AND THIEF IN CHICAGO" IS BIGGEST CURRENT  
TOPIC OF CONVERSTATION AT MEETINGS OF HOODLUM LEADERS. *PC INFORMANT*  
STATED EACH LEADER IS SEARCHING HIS BACKGROUND TO RECALL  
ANY CONTACTS , CONNECTIONS OR RELATIONSHIPS IN PAST WITH

BURGLARS AND THIEVES IN ORDER TO PREPARE TO COMBAT ANY ALLEGATIONS WHICH MAY BE MADE AGAINST THEM, PARTICULARLY THOSE WHICH MIGHT TEND TO INDICATE A CONSPIRACY BETWEEN THE HOODLUM LEADER AND THE BURGLAR OR THIEF.

B8, WHO CLAIMS HE RECOGNIZED PERIL OF ASSOCIATION AND RELATIONSHIP WITH THIEVES AND BURGLARS LONG AGO, INDICATED ALEX<sup>ST</sup> GROUP HIGHLY CRITICAL OF "WEST SIDE," NAME HE USES TO INDICATE ITALIAN MEMBERS OF ORGANIZED CRIME, FOR THEIR LONG ASSOCIATION WITH THIEVES AND BURGLARS WHO ARE NOW COOPERATING WITH CHICAGO DIVISION SINCE ALEX GROUP FEARFUL THAT IF "WEST SIDE" IS TIED INTO CONSPIRACIES THEY ALSO MAY BE THROUGH ASSOCIATION WITH "WEST SIDERS."
