Remylet to Bureau 8/29/72; LHMs dated 8/28/72, 8/31/72 and 9/6/72, and report of SA WILLIAM F. ROEMER, JR., dated 9/19/72 at Chicago. (u)

On 9/7/72, a copy of referenced LHM dated 8/28/72 was furnished to the Direccion General de Seguridad (Directorate General of Security - DGS), Spanish National Police, Madrid, Spain. Subsequently, pertinent data from the other LHMs and report were also furnished to the DGS. (S)(u) per G-1

On 10/16/72, the DGS advised that to date their inquiries have failed to determine subject's possible whereabouts in Spain. In addition, they advised that they could develop no information concerning SAMUEL GIANCANA. The DGS further advised that a general lookout notice has been published in an effort to locate subject, as well as GIANCANA should he come to Spain. (S)(u) per G-1
