Legat, Madrid, letter, 12-19-72. (u)

As Bureau and Chicago are aware, [MEX-334-PCI] advises that CAIN is currently in Mexico City; therefore, it is not considered that Legat, Madrid, need conduct further inquiry concerning him and his location. (u)

However, for the information of Legat, Madrid, source advised there is a report that CAIN's daughter is married to the son of an American Embassy official in Madrid and CAIN has some limited contact with this functionary because of this relationship. (u)

Chicago requested to advise Legat, Mexico City, if it was ever ascertained if the CAIN who was in Acapulco in January, 1972, was the Subject. (u)
