MEX-56, who has furnished reliable information in the past, furnished the following information on 6/6/62:

GUSTAVO DIAZ ORDAZ, Mexican Secretary of Interior, received a complaint, complainant not identified, about 1:00 P.M. on 6/4/62, to the effect that the subject was conducting investigation of Mexican citizens. DIAZ ORDAZ ordered the subject's immediate apprehension, which was accomplished, and after interview of the subject, he was deported from Mexico as an undesirable aboard Braniff Airways flight departing Mexico City 3:45 P.M. on 6/4/62 en route San Antonio and Chicago. During interview of the subject by Mexican Interior agents, he confessed killing a Chicago gangster while he was employed by the Chicago Police Department. He indicated he was in the private investigative business in Mexico, together with Mexican citizens SAMUEL L. RODGERS and DANTE HERRERA.

At the time the subject was apprehended, he was in possession of an official credential issued by the Ministry of Public Credit (which that Ministry denied having issued), brass knuckles, and an Italian-made automatic pistol. The
