Any information obtained by the Miami Division through interview of ANGEL SOLANO should be reported under the UPUC caption in accordance with instructions contained in referenced Bureau airtel dated November 16, 1961.

Kane Service, a Chicago detective agency and watchman service, 510 North Dearborn Street, apparently has no connection with this matter.

For the information of the Offices receiving copies of this report, reference is being made to Miami letter to the Director dated 11/14/61 entitled "JAMES WILLIAM BECK; ET AL, CENTRAL AMERICAN DEMOCRATIC FRONT, IS - NICARAGUA; RA - NICARAGUA" (OO: Chicago) which contained therein a characterization of SAUL SAGE who furnished the original information concerning this matter. MM 639-S who has been involved in Cuban revolutionary activities during the past four years and has furnished reliable information in the past, advised on 9/5/61 that SAUL SAGE, an American, had been frequenting the hang outs of Cuban revolutionists in Miami, Florida. MM 639-S stated that SAUL SAGE is highly unreliable and psychotic and together with other individuals thinks up irresponsible plans and dreams from day to day that have no chance of success and which they never really intend to put into practice. SAGE and his associates have no organizational ability, no money, are unemployed and enjoy playing the part of being considered "soldiers of fortune" (u)

Careful consideration has been given to each source concealed and T symbols were utilized only in those instances where the identities of the sources must be concealed.
