subject in accordance with existing instructions relating
to interviews with security subjects. Care will be exercised
to protect the original source in this matter. No direct
questions will be asked during the interview which will dis-
close to the subject the identity of the [Official] or the
[establishment] contacted, the method used in the contact, or
the fact that we are aware of the contact. The interview
will be conducted in a manner so that the subject will
volunteer the details of the contact.

If the subject is cooperative, no affirmative
steps will be taken during the initial interview to direct
his activities, but a separate communication will be directed
to the Bureau setting forth the results of the interview and
requesting authority to recontact the subject as a potential
security informant or double agent.

1. Subject resides at 1415 Hudson Avenue, Chicago,
Illinois, is an architect, employed as Project Manager by
Donald Pyskacek Architects, 55 East Washington Avenue, Chicago,
Illinois. He is an American citizen and was born 10/30/32
at Erie, Pennsylvania.

2. Subject is single.

3. On 10/29/59 subject was contacted by VLADISLAV
MIKHAILOVICH ABARCHALINE, a clerk at the Soviet Embassy,
Copenhagen, Denmark, who is reported as probably a cadre
worker of the KGB, a Residency in Copenhagen. ABARCHALINE
indicated he and ALLEY would go to a quiet spot where they

could talk in peace. They met at 8 P.M., 10/29/59, at Town Hall Square, Copenhagen, and proceeded to a small cafe where ABARCHALINE obviously gave ALLEY some books and periodicals. (S)

ALLEY again met with ABARCHALINE on 11/5 and 16/59 at Copenhagen, Denmark. On 11/5/59 ALLEY indicated he would introduce ABARCHALINE to KANTOR, identified as MARVIN KANTOR, a United States citizen studying in Europe, and it was noted that MARVIN KANTOR was present during a part of the time consumed by the latter two meetings. On the 11/5/59 date, ABARCHALINE and ALLEY visited the latter's home and ABARCHALINE again apparently gave ALLEY a book. (S)

4. Investigation fails to indicate that subject has ever engaged or been suspected of engaging in any subversive activity other than the implications of activity described in Item 3.

5. Subject is not married. Current investigation has revealed no subversive activity on the part of his parents.

6. Subject's potential as an informant or double agent is unknown. The interview is expected to determine his potential in these regards. (S)

7. As a result of subject's contacts with ABARCHALINE, the District Intelligence Office, Fourth Naval District, Philadelphia, Pennsylvania, has expressed an interest in this matter since subject's father is employed by the General Electric Company, Erie, Pennsylvania, with access to secret material. It is desirable that the allegations against subject should be resolved so that the matter of his father may be appropriately dealt with by Naval authorities. There is no information available to indicate the undesirability of this interview. (S)

8. This interview is expected to develop detailed information regarding the contacts of ALLEY by a Soviet Embassy employee at Copenhagen, Denmark, and the purposes of such contacts. It is expected also that subject's potential as an informant or double agent will become known as a result of this interview. (S)

Approach to the subject will be on the basis that it is known that he had traveled in Western Europe and the Scandanavian countries during 1959 and 1960 and to determine if, during his travels or residence abroad, he was approached by any individuals who were employees or citizens of Soviet or satellite countries. It will be pointed out to the subject that other individuals who have traveled and resided in Europe have been contacted by such persons. It is felt that such an approach is general, yet sufficiently specific to allow subject to recall contacts with citizens of other countries and offer him the opportunity to volunteer the details of the contacts which are the basis for this investigation. ~~S~~
