It will be noted that the applicant is currently being investigated under caption "MELVIN KANTOR, ESP-R, MARVIN KANTOR, IS-R (DENMARK), Bufile 105-77772, WFO 105-34683. It would appear that the MELVIN KANTOR who was reportedly recruited in 1961 on ideological grounds by VLADIMIR VLADIMIROVICH IVANOV and others is probably identical with the applicant, however, to date, this has not been definitely established. It is to be noted that in WFO let in reference file dated 5/18/64, that there is very little likelihood that the applicant will be employed by USIA.

With the above exception it would appear that all information received by CIA was furnished to CSC and therefore none of the foregoing information is being
