Enclosed herewith for the Bureau are twelve copies of a letterhead memorandum, dated and captioned as above.

Copies of the memorandum are being furnished to INS, Newark, and Miami, New York, and San Juan for information because of their interest in the activities of JURE.

One copy of the memorandum is being furnished to New York for transmittal to the United States Customs, New York, in view of the fact this matter falls within the jurisdiction of the U.S. Customs.

NK T-1 is NK 2381-C-TE. This informant has advised that he has never seen unsub and thus cannot identify a photograph of DIEGO ABICH as being identical to unsub. Informant states he has talked to unsub only on the telephone. This information was paraphrased in the letterhead memorandum to protect the identity of the informant.

NK T-2 is JORGINA ABICH, 114 Clifton Place, Jersey City, New Jersey (nurses' residence), Jersey City Medical Center) (by request).

It is not felt that further investigation is warranted in this case as it does not appear at this time that DIEGO ABICH will be a participant in any military activities against Cuba planned by JURE.
