Enclosed herewith are 9 copies to the Bureau and two copies to Miami of an LHM together with a memorandum of evaluation dated and captioned as above. The informant referred to in the LHM is PEDRO FERNANDO ENTENZA ESCOBAR, PSI, who furnished the information to SA JOHN G. GOEDTEL.

Informant was unable to recall with certainty the source of the information incorporated in the LHM but believed that he heard it from ROGELIO CISNEROS who had recently been in Washington, D. C. The informant described CISNEROS as a former teacher in the school system in Camaguey Province, who organized the underground against CASTRO in that province. According to the informant, CISNEROS is currently employed by a construction company having business in Latin America. His purpose for coming to Washington, D.C., was to contact officials at the Pan American Union and Inter-American Development Bank.

WFO files reveal that ROGELIO CISNEROS DIAZ was a national leader of the Junta Revolucionaria Cubana and member of the National Directorate from Miami, Florida, who has since resigned from that organization.

WFO indices contain no information identifiable with (FNU) DONEVESTEZ.

Miami might desire to identify DONEVESTEZ through established sources if that individual is not already known to the Miami Office for the purpose of interviewing him concerning his alleged discussions with FIDEL CASTRO in Camarioca, Cuba, in the recent past.
