- D. Locket containing picture of victim HEMBROFF's deceased husband, possibly bearing latent prints of Unknown Subject; was. ARTHUR GRANT, et al.

Miami Airtel dated May 14, 1953 reflects Confidential Informant MM 438 C advised a Special Agent of the Miami Office that subject "PEARSON" might be identical with conman (FNU) MASON who visited Confidential Informant March, 1953, and drove a 1950-51 Mercury with Arkansas License, and who resides in Pine Bluff, Arkansas. Confederate of MASON, viz., JAMES McDOUGAL, wa. Scotty, FBI Number 477142, according to Confidential Informant, has fix with County Attorney and Sheriff's Office, Springfield, Illinois. Confidential Informant states McDOUGAL's description is similar to that of Unknown Subject; was. ARTHUR GRANT, et al. (Note fact that Evidence Item B. was signed by Unknown Subject; was. JOHN PEARSON, et al, on second "date" with victim OLTZ back in August 28, 1952 in the name of "J. MASON, Rt. 1, West Memphis, Arkansas." At this time, Unknown Subject; was. JOHN PEARSON, et al, was driving a 1950-51 dark blue Mercury.)

Miami Airtel dated May 18, 1953 indicates Conman VICTOR ~~PERIERA~~ FIA may be identical with JOHN A. TABOR or Mr. BUTLER and that C. C. ~~LUNDEGAARD~~, wa. Doc ~~Woods~~, may be identical with Unknown Subject; was. JOHN PEARSON, et al. FIA

In view of the above, the FBI Laboratory is requested to conduct the following examinations:

1. Will, from Items C. and D., attempt to develop latent prints. Will compare any latents developed on these items together with any possible developed on the 29 United States Savings Bonds previously submitted in Indianapolis letter dated May 6, 1953 with EUGENE FISHER LONDOS, FBI Number 4133415; JAMES ~~McDOUGAL~~, wa. Scotty, FBI Number 477142; C.C. LUNDEGAARD, wa. Doc Woods; and VICTOR PERIERA. J. M. M.
2. Will appropriately cause the handwriting specimens submitted to be searched through the Fingerprint Cards of similar name or description or alias and the National Fraudulent
