FOR FIVE THOUSAND DOLLARS DRAWN AGAINST THIS ACCOUNT PAYABLE TO RICHLUND OIL COMPANY. NO LARGE WITHDRAWALS SINCE THAT TIME. NO SAFE DEPOSIT BOXES FOR SUBJECTS, MRS. PEREIRA, OR MRS. HARGELL, AT MOUNTAIN STATES BANK. WHILE IN DENVER JUNE FIFTH PEREIRA REMOVED BRADING'S PERSONAL EFFECTS FROM CAMELIA HOUSE APTS. AND HAD STORED AT GRAY MOVING AND STORAGE CO., DENVER. THIS COMPANY ALSO HOLDING TEN THOUSAND POUNDS OF HOUSEHOLD FURNISHINGS SHIPPED TO PEREIRA FROM DALLAS IN NOVEMBER FIFTYTWO. MRS. PEREIRA PAYING STORAGE CHARGES. NO FORWARDING ADDRESS ON ANY OF THIS MATERIAL. WHILE AT COSMOPOLITON HOTEL, DENVER, ON JUNE SECOND PEREIRA PHONED A MR. SYLVESTER AT NYC TELEPHONE NUMBER PLAZA NINE TWO FIVE FIVE FIVE. ALSO MADE CALLS TO NYC ON JUNE NINTH AND TENTH. CONFIDENTIAL SOURCE UNABLE TO LOCATE BILLINGS ON LATTER CALLS TILL JUNE FIFTEENTH. DN.-119-C REPORTED TODAY HE HEARD BRADING NOW IN EITHER NEW YORK OR BALTIMORE. NEW YORK ADVISE BALTIMORE IF BRADING NOT LOCATED IN NYC.
