FERRIRA RESERVED ROOM ONE TWO FIVE FOR CLARK ON JULY EIGHTEEN INSTANT. INFORMANT ARRANGED TO MOVE IN ROOM ONE TWO FOUR NEXT TO CLARK AND ADVISED AT APPROX. TWO P.M. JULY TWENTYFIVE THREE UNKNOWN WOMAN AND TWO UNKNOWN MEN VISITED CLARK. CLARK AND TWO MEN STAYED IN ROOM WHILE WOMEN WERE AT POOL. AT THREE P.M. ALL LEFT HOTEL. AT NINE THIRTY P.M. SAME DATE MR. AND MRS. PERKIRA PICKED UP CLARK AND LEFT HOTEL. RELET FROM DALLAS REFLECTED PERKIRA AND BRADING WERE SEEN FREQUENTLY IN DENVER, COLO. WITH KNOWN CRIMINALS, SUCH AS ARTHUR L. CLARK, FORMER MEMBER OLD DETROIT PURPLE GANG, AND CLYDE AND EUGENE SMALLDOME, CONFIDENCE MEN. LA INDICES REFLECT ARTHUR L. CLARK, FBI NO.
