REQUILLET TO BUREAU JULY 31, 1953. DN-119-C REPORTED ON 7-31-53 THAT MONROE
MARKS, 1601 CHERRY ST., DENVER, TELEPHONE FLORIDA 6011, HAS BEEN FINANCIAL
BACKER OF CHARLES CORLEY IN OPERATION OF LEET CORP., 233 SO. BEVERLY DRIVE, LA.
TELEPHONE CRESTVIEW 5-3697. CORLEY RESIDES 305 SO. CLARK, BEVERLY HILLS,
TELEPHONE CRESTVIEW 5-2761. INFORMANT STATES LEET CORP. IS DISTRIBUTOR OF
COIN OPERATED VENDING MACHINES AND MARKS WAS IN LOS ANGELES RECENTLY AND SOLD
HIS INTEREST IN LEET CORP. TO CORLEY. UPON RETURN TO DENVER ABOUT A WEEK AGO MARKS
TOLD INFORMANT HE SAW PEREIRA AND BRADING IN LOS ANGELES AND THEY WERE BUYING
INTO LEET CORP. AS ASSOCIATES OF CORLEY. INFORMANT SAID MARKS RELATED THAT
BRADING TOLD HIM THAT HE AND PEREIRA WERE GOING TO "BEAT" THE CASE FOR WHICH
THEY WERE CONVICTED AND THAT THEY "ALREADY HAVE SEVEN SUPREME COURT JUDGES
WHO WILL RECOMMEND THAT THE CASE BE SENT BACK TO THE TRIAL COURT FOR REHEARING."
INFORMANT STATED THAT ARTHUR LEWIS CLARK WAS ALSO IN LOS ANGELES LAST WEEK AND
HE HEARD THROUGH MARKS THAT CLARK IS TRYING TO ACQUIRE AN INTEREST IN LEET CORP.
ACCORDING TO INFORMANT CLARK CONSIDERS PEREIRA AN "EASY TOUCH" AND WILL KEEP
IN CLOSE CONTACT WITH HIM AS LONG AS PEREIRA IS MARRIED TO MRS. LITTLE, WHO IS
REPORTED TO BE WORTH SEVERAL MILLION DOLLARS. AS PREVIOUSLY REPORTED CLARK
IS ALSO AN ASSOCIATE OF CHARLES CORLEY. LA NOTIFY INTERESTED OFFICES IF BRADING
IS IN LOS ANGELES AREA.
