SAN ANTONIO AND PHOENIX, PEREIRA RA AND BRADING CONVICTED USDC, EL PASO, TEXAS, JAN. FIFTEEN, FIFTYTWO, AND SENTENCED TO TWELVE YRS. WRIT OF CERTIORARI GRANTED JUNE FIFTEEN LAST. AT PRESENT PEREIRA AND BRADING EACH ON FIFTEEN THOUSAND DOLLAR BOND AWAITING DECISION SUPREME COURT. BRADING-S PRESENT WHEREABOUTS UNKNOWN.
