LA THREE SIX TWO SIX DASH C ADVISED PEREIRAS RECEIVED FLOWERS ON AUGUST SEVEN LAST FROM QUOTE JIM UNQUOTE. CLARK JR. GEORGIA ST., VAN COUVER, BRITISH COLOMBIA, DATED AUGUST SEVEN LAST, TWELVE ZERO FOUR P. M. ORDERING FLOWERS. MESSAGE STATED QUOTE CONGRATULATIONS AND MANY MORE HAPPY YEARS, SIGNED JIM UNQUOTE. IT IS BEING LEFT TO BUREAU-S DISCRETION TO NOTIFY SEATTLE TO MAKE INVESTIGATION RE WHEREABOUTS OF SUBJECT BRADING AT VAN COUVER, BRITISH COLOMBIA. LA DOES NOT POSSESS ANY INFO REFLECTING WHETHER BRADING-S DEPARTURE FORM U. S. CONSTITUTES VIOLATION OF BOND. LA IS FORWARDING BACKGROUND AND PHOTOS OF SUBJECTS BRADING AND PEREIRA TO SEATTLE TODAY.
