BE READY TO DEPART AT A MOMENTS NOTICE TO LAND AN ALPHA SIXTYSIX GROUP IN CUBA. HE ADVISED THAT A THIRTYONE FOOT BOAT, NOT OTHERWISE IDENTIFIED, WOULD BE USED. HE INSTRUCTED ONE MEMBER OF THIS GROUP TO CONTACT HIM AT EIGHT PM JULY EIGHTEENTH, AT THE HOME OF OSIEL GONZALEZ. THE THIRD SOURCE RECEIVED THE IMPRESSION THAT THIS OPERATION MIGHT TAKE PLACE SHORTLY AFTER EIGHT PM JULY EIGHTEENTH OR THAT OROSCO MIGHT ISSUE ADDITIONAL INSTRUCTIONS AT THAT TIME. ](S)(u)
