Information from REY was furnished to the District Supervisor of the Federal Narcotics Bureau, Atlanta, by letter dated March 25, 1968.

Interview of IGNACIO GUTIERREZ, reflected on Page 8 - 9 of this report was also set forth in aforementioned report of SA STOY dated March 12, 1968.
