GRANELLO told the source that he wants him to interest DeJOIE in this matter.

GRANELLO told the informant that his contacts with NOBLE are ANTHONY and JOSEPH STACCI, aka TONY and JOE ROGERS. It should be noted that JOE STACCI is a Bureau fugitive and attempts are presently being made to locate him through the informant, GRANELLO told the informant that TONY and JOE ROGERS are extremely close to NOBLE.

Concerning the \$500,000.00 requested by NOBLE GRANELLO told the informant that if this matter is successful, he will take \$300,000.00 of this amount from NOBLE and split it with the informant evenly. He stated that of the remaining \$200,000.00 TONY ROGERS will demand \$100,000.00 from NOBLE.

GRANELLO also told the informant that, to protect the \$1,500,000.00, this money could be placed in escrow until DUVALIER has left Haiti.
