On February 4, 1958, PCI GOFFREDO CELLINI, whose identity must be kept confidential and who is employed at the gambling casino at the Hotel Nacional, advised that a group of individuals composed mostly of Italians had checked into the Nacional and that he was suspicious that they might be either connected with gambling operations in the New York - New Jersey area or hoodlums in that area since two of the individuals, PETER FOLLINI and ALBERT NAFT, claimed to have known CELLINI several years ago when CELLINI was engaged in gambling activities in the States. *(X) u*
