an interview with BARTONE, Miami would be so advised. In view of this fact, it is not recommended that BARTONE be interviewed in subject case at this time. UACB, this will not be done. In view of BARTONE's past record, it is doubtful as to whether he would furnish accurate information regarding any contact made with him by A. W. LAPPIN. It is recommended that the Washington Field Office, in connection with its proposed interview of A. W. LAPPIN, keep in mind the contact made from his room at the Leamington Hotel to DOMINICK BARTONE's residence on February 23, 25, and 26, 1963. If LAPPIN will furnish substantial information regarding this contact, it is recommended that consideration be given to then interviewing BARTONE. However, until such time as BARTONE is made available for interview in the case mentioned above (Bufile 29-31889), it is not believed interview with him is desirable.

Information in this report is also set out in report captioned, "PAUL MAGLOIRE, IS - HAITI," (Miami File 105-7441) (Bufile 105-55981).

FRANK NATHAN has been a subject in the case entitled, "ABRAHAM TEITELBAUM, was.; ET AL, PERJURY - BRIBERY," (Miami File 74-48) (Bufile 74-1459). There appears to be no objection to direct interview with FRANK NATHAN in this matter.
