On 1/8/63, Mrs. OLGA TAMAYO DE GUTIERREZ,
4605 East 8th Court, Hialeah, Florida, contacted the Miami
Office and advised that she wished to furnish additional
information to clarify the telephonic contact made with
her by the subject in 12/62, as set forth in Miami relet
dated 1/3/63. Mrs. TAMAYO stated that due to her heavy
social schedule during the holiday season, and due to the
large volume of business at her place of business (she operates
an auto insurance agency, driving school, auto rental, etc.)
she was somewhat confused concerning the dates on which
ORGANVIDEZ contacted her by telephone.

Mrs. TAMAYO stated that ORGANVIDEZ initially
contacted her at approximately midnight on 12/24/62
(Christmas Eve) to advise her that he respected her most
highly, that he felt that she merited being treated like
a member of his family, and regretted the inconvenience she
had suffered because of his stay at her home.
