AT MIAMI, FLORIDA

Will follow efforts of ROBERT HOPKINS, CIA, Miami, to obtain information in possession of CIA, Miami, in instant matter, and take action called for by such information. (u)

- ADMINISTRATIVE -

Instant report is classified "SECRET", as information from the United States Department of State, as well as information furnished by CIA, was so classified. (u)

PEDRO DIAZ LANZ and MM 492-S advised the only organization of former members of the Cuban Rebel Air Force in the United States to their knowledge is the organization within the Frente Revolucionario Democratico (FRD). It is noted that although DIAZ LANZ is in the FRD, it is not believed he is in that section. As pointed out in referenced Miami airtel dated October 31, 1960, ROBERT HOPKINS, CIA, Miami, advised at that time that CIA, Miami, had made inquiries in this matter among the former members of the Cuban Rebel Air Force associated with the FRD, along with other inquiries in other places. He said the full results of the CIA inquiry were not known to him. On December 12, 1960, HOPKINS was requested to ascertain what information CIA, Miami, has in its possession about captioned organization, its membership and leadership, and about LUCY VILLEGAS. On December 19 and 27, 1960, HOPKINS advised he has not, as yet, been able to obtain that information, as the person who would know has not been available. He said he would attempt to obtain that information in the near future. (u)
