NOTE: Subject, naturalized citizen of Cuban origin, has worked as merchant seaman and was reported as CP member but has denied CP membership. Subject was anti-Batista prior to Castro takeover and served in Castro army after Castro came to power. He subsequently turned against Castro, engaged in clandestine anti-Castro activities, and was captured by Castro forces in September, 1961. He was released in April, 1963, through efforts of Attorney James B. Donovan and came to U. S. He has been cooperative with Miami Office and furnished considerable information including details of his own activities. In sworn affidavit in 1959, subject was reported by Brown as member of CP in 1948. Miami in rerep set out lead for Kansas City to interview Brown and show him pictures of subject to be certain this is individual Brown identified as CP member.

NOTE CONTINUED:

Bufiles indicate Brown is former CP member who was informant for Boston Office in 1953. He was discontinued as informant because he was unreliable. He is presently serving prison sentence for acquiring and obtaining marijuana. Since Brown furnished sworn affidavit to INS and due to the fact he is known to be unreliable, it is felt no useful purpose would be served in interviewing him concerning his identification of subject as CP member in 1948.
