Miami will attempt to cover activities of Gen. WESSIN through interviews with him, as well as through established sources. During interviews to date he has not furnished any significant info re his activities, although he remains courteous and receptive and reiterates his desire to cooperate with the U.S. Govt.

Enclosed LHM sets forth info from ELISEO GOMEZ which conceals his identity with T symbol. During interview he indicated he was in the employ of another U.S. Govt. agency. He admitted having data re Haitian interests and having contacted WESSIN, but would not divulge same without clearing with the other agency.

Miami has noted in previous correspondence that WESSIN is closely associated with Cuban exiles MARCOS DIAZ LANZ and ANTONIO LLANOMONTES, noting further that info developed in past re these individuals indicates they are probably associated with WESSIN for mercenary reasons. Because of these probable intentions, it does not appear these individuals will provide this Bureau current and pertinent info re WESSIN's activities.

Other Cubans like GOMEZ who are apparently close to WESSIN in some instances have contacts with CIA and cannot be expected, since they are receiving CIA pay, to provide the same data to this Bureau for fear of jeopardizing their CIA connections. (S)(u)

In this regard it is noted MM-761-S has stated he personally knows that numerous Cubans [seek and have CIA connections in the Miami area, although in many instances CIA does not get value received for this coverage.] (S)(u)

It is probable that ELISEO GOMEZ is the source of some of the info re WESSIN contained as enclosure in reBuairtel re WESSIN. Because of his connections with WESSIN and his expressed desire to cooperate with the Govt., Miami will endeavor to develop a close relationship with GOMEZ, recognizing his primary allegiance [will probably remain with CIA] and a certain duplication probably will result in obtaining info from him. (S)(u)

At the same time, Miami is attempting to have our own informants align themselves with WESSIN and/or the Cubans close to him insofar as time permits, noting they have other assignments relating to the Cuban situation in Miami.
