DO NOT DISSEMINATE

MARIE ZETLIN advised KRAVCHENKO met one individual through her. MAX EASTMAN believes first met KRAVCHENKO at home of SOL LEVITAS in Brooklyn, NY. Does not believe KRAVCHENKO met anyone through him. States BORIS SOUVARINE is best anti-Communist intellectual known to him. Information concerning JOAQUIN MAURIN and SOUVARINE set forth. Contact with KRAVCHENKO, background and other information concerning BORIS NICOLAEVSKY set forth. NICOLAEVSKY does not appear to be good suspect for Tulip, but cannot be entirely eliminated. HAROLD ISAACS eliminated as suspect.
