On 5/20/68 MM [1228]<sup>(S)</sup> S advised that Lilia Emilia Cuesta Perez was the half-sister of Antonio Cuesta Valle, a hero of the anti-Castro forces currently in jail in Havana, Cuba. She was the daughter of Valle's father, had been adopted by the family of Lilia Perez Arias, her step-mother, and lived with the Arias family at Calle 5a #336, Casino de Deportivo, Havana. [As a result of several visits to the prison hospital to see Valle, she met Raul Alfonso Roldan, a Department of State Security (DSE) officer, who invited her to visit him at DSE headquarters. During February 1968, Emilia visited DSE headquarters on several occasions for interviews with Roldan and others who questioned her at length concerning the sympathies and activities of her family and Valle. She cooperated with DSE authorities and apparently furnished them whatever information she had.]

The following references pertain to the Cuban counterrevolutionary and anti-Castro activities of Antonio Cuesta Valle from January 1959 to 5/29/66 in Miami, Bahamas, Cuba, Dominican Republic and Puerto Rico. Cuesta, who was an early supporter of Fidel Castro, belonged to several middle-of-the-road exile organizations, headed the CL, served as Lieutenant of the Cuban Department of Logistics of the National Revolutionary Police, Havana, a former investigative branch of the Cuban Government, belonged to the MRR and was second in command of DIER. He attended meetings and affairs, was in contact and associated with numerous individuals. Cuesta anticipated, led and/or participated in military operations against the Cuban Government including an attack on a Russian vessel at Caibarien and a raid on the residence of President Osvaldo Dorticos Torrado in Havana City. He accepted donations and worked toward unifying anti-Cuban revolutionary organizations. Cuesta was jailed in Cuba as an aftermath of the suicide of the Minister of Public Works and as of 3/16/59 he
